Log Files

- 1. Program description:** This campaign allows our opted-in applicant to receive messages for appointment reminders at the dealership, as well as a direct sms message from their assigned dealership agent.
- 2. Frequency:** You will receive one message as an appointment reminder one hour before your appointment, and vital messages from your dealership's assigned salesman may vary in amount and frequency during normal business hours.
- 3. Opt-out:** You can cancel the SMS service at any time. **Just reply back with STOP.** After you send the SMS message STOP to us, we will send you an SMS message to confirm that you have been unsubscribed. After this, you will no longer receive SMS messages from us. If you want to join again, just sign up as you did the first time and we will start sending SMS messages to you again.
